Roll out of IPC Precautions in HCFs

County Visit Program

1. Meet with County Authorities, HCF Managers, and Community Leaders
2. Health Center and Hospital training & on-site orientation
3. Health Clinic training & on-site orientation

Target Duration: 3-4 days

I - Meeting with County Authorities, HCF Managers, and Community Leaders

1. Greet local authorities
2. Introduction of National/International Facilitators. **It is essential that facilitation teams have expertise in local patient care practices, IPC, and Water and Sanitation.**

Audience for Day 1:

- Local health authorities
 - Director and designated IPC Focal Point from each health center (HC) and Hospital (2pp)
 - Officer in Charge (OIC) from each clinic (1p)
 - Community leaders
3. Presentation of what's planned for the country, and specifically for the county in terms of the IPC package. Package is comprised of a three pronged-approach:
 - Training
 - Supplies
 - M&E
 4. Presentation on main things all should know about Ebola and describe the content of training materials and tools
 5. Training on how to establish Ebola Care centres

Duration: All Day



II - Model for Hospital (~100 HCW) & Health Center (~50 HCW) Training & on-site orientation

One team per Hospital or Health Center per day includes: 3 facilitators (1 Local Patient Care, 1 IPC, 1 Water & Sanitation). The training will consist of 3 components

1. Combined training
2. Breakout sessions
3. Walk around

8:00 am -12 midday: combined training for all staff

1. The program for the day
2. Use flip chart to learn of the audience's learning expectations of the training
3. Current situation overview
4. What all should know about Ebola
5. The essentials of PPE, case management, environmental cleaning and waste management
 - Include demonstrations and trials of PPE and chlorine preparation
6. What's the strategy to stop the outbreak (1 slide w/ framework)

9:45 – 10:00: Coffee Break

12:00 – 1300: Lunch

1pm to 3 pm: 3 Breakout Sessions: Targeted trainings

Type of Activity	Audience
Clinicians	Nurses, Physician Assistants, Medical Directors, midwives
Disinfection, environmental cleaning and waste management	Staff in charge of cleaning and disinfecting
Ancillary staff	Lab technicians, pharmacy, security



3:00pm: Reconvene all staff to review the day and learning expectations

3:30 – 5:30: Walk around to look at patient flows, holding spaces, changing areas, waste flows, PPE storage. Should be lead by medical and nursing Director plus a Focal Point designated to follow up on application of measure. Mock patient run through and establish processes going forward. Demonstration of the monitoring and evaluation tool.

Materials needed:

- Audit tools
- SOPs
- Posters, Flipcharts, Projector (if available), PPE, brochures

III - Model for Health Clinic (~15 HCW) Training & on-site orientation

Health clinic training package will vary by county and district.

Teams should split so as to cover each facility in half a day. 1-2 facilitators should be accompanied by local health staff.

The package will be as for the large centres except will not have the breakout sessions.

1. Combined Trainings
2. Walk around and review of patient and waste flows, use monitoring and evaluation tool

Duration: ~3-4 hours
