

Indonesia

GENERAL INFORMATION

Indonesia is a country with an approximate area of 1905 thousand square kilometers (UNO, 2008). The population is 232,516,771 and the sex ratio (men per hundred women) is 99 (UNO, 2009). The proportion of the population under the age of 18 years is 31% and the proportion above age 60 is 5% (UNO, 2009). The literacy rate is 97% for men and 96% for women (UN Statistics, 2008). The life expectancy at birth is 66 years for males and 69 years for females (UNO, 2005-2010). The healthy life expectancy at birth is 60 years for males and 69 years for females (UNPD, 2010). The country is in the lower middle income group (based on 2010 World Bank criteria). The total expenditure on health as a percentage of gross domestic product is 2.36% and the per capita government expenditure on health (PPP int. \$) is \$42.0 (WHO, 2006). Suicide rate information is not available. In Indonesia, neuropsychiatric disorders are estimated to contribute to 10.7% of the global burden of disease (WHO, 2008).

GOVERNANCE

An officially approved mental health policy exists and was approved, or most recently revised, in 2001. Mental health is specifically mentioned in the general health policy.

A mental health plan exists and was approved, or most recently revised, in 2001. The mental health plan components include:

- Timelines for the implementation of the mental health plan.
- Integration of mental health services into primary care.

Dedicated mental health legislation does not exist. However, legal provisions concerning mental health are covered in other laws (e.g., welfare, disability, general health legislation etc.).

Note: For reference, Health Law number 36/2009, articles 144 to 151, relate to mental health. To implement this law, a draft of the Government Regulation on Mental Health has been finalized and submitted to the Ministry of Justice and Human Rights.

FINANCING

Mental health and mental hospital expenditures by the government health department/ministry are not available.

MENTAL HEALTH CARE DELIVERY

Primary Care

Prescription regulations authorize primary health care doctors to prescribe and/or to continue prescription of psychotherapeutic medicines. In contrast, the department of health does not authorize primary health care nurses to prescribe and/or to continue prescription of psychotherapeutic medicines. Similarly, official policy does not permit primary health care nurses to independently diagnose and treat mental disorders within the primary care system.

The majority of primary health care doctors and nurses have not received official in-service training on mental health within the last five years. Officially approved manuals on the management and treatment of

mental disorders are available in the majority of primary health care clinics. Official referral procedures for referring persons from primary care to secondary/tertiary care exist, as do referral procedures from tertiary/secondary to primary care.
