


# COVID-19 and HIV

As traditional HIV testing services may be interrupted because of the COVID-19 response, CDC's HIV self-testing resource page provides information about self-testing.

- New Application Deadline for EHE Implementation Funding
   CDC has delayed the deadline to apply for FY20 funds to implement the EHE initiative; applications are now due May 1, 2020.
- Guidance on Flexibility of Federal Financial Assistance
   CDC posted guidance on Flexibilities Available to Applicants and Recipients of Federal Financial Assistance Affected by COVID-19. Based on two Office of Management and Budget memoranda, CDC intends to extend these time-limited flexibilities wherever possible.
